The Officers of the ICC Region I Chapter are proposing to amend Section 2 of Article X of the Chapter Bylaws to reduce the length of the Officers' terms from two (2) years to one (1) year. In response to challenges faced during the Covid-19 pandemic, the Chapter Bylaws were amended to require two-year terms for each Officer. However, in an effort to increase participation on the Board by reducing the overall time commitment associated with serving as an Officer on the Board, it is proposed to amend the Bylaws back to the pre-Covid language as follows:

Current Bylaws:

Section 2. Terms

The Council representatives from each state shall elect their Officer for terms of two years at an annual meeting of the Chapter. The Officers shall hold office until the conclusion of the annual meeting that occurs two years after their election. In the event there are no candidates for an office, the current Officer shall continue in that capacity until successors are elected.

Original Bylaws Prior to Covid:

Section 2. Terms

The Council representatives from each state shall elect their Officer for terms of one year at an annual meeting of the Chapter. The Officers shall hold office until the conclusion of the annual meeting. In the event there are no candidates for an office, the current Officer shall continue in that capacity until successors are elected.

Proposed Change:

Section 2. Terms

The Council representatives from each state shall elect their Officer for terms of one two years at an annual meeting of the Chapter. The Officers shall hold office until the conclusion of the annual meeting that occurs two years after their election. In the event there are no candidates for an office, the current Officer shall continue in that capacity until successors are elected.

In accordance with Section 2 of Article XII, this proposed Amendment to the Bylaws will be posted on the Region I Chapter's website for a minimum of 30 days, and a vote will be held at the next All Chapter meeting that is scheduled for October 19th. A two-thirds majority vote of the Chapter members is required for adoption. The amendment shall become effective immediately upon approval.
